

**Iowa Area AWSC Meeting  
Marshalltown, IA  
January 21, 2018**

Virginia B., Chairperson, opened the meeting at 9:03 am. Total attendance was 26 of which 23 were voting members of the AWSC.

**Secretary Report (Linda A)**: The minutes from the 2017 Fall Assembly were mailed electronically earlier to be read before the meeting; they were not read during the meeting. There were no changes or additions. A consensus vote was taken and approved. The minutes will be filed.

**Treasurer Report (Jean L.)**: Read the financial statement from October 2, 2017 – December 31, 2017. Balance brought forward was \$30,840.77. Total receipts year-to-date were \$45,284.15. Total disbursements for the year were \$22,570.45. Balance brought forward on December 31, 2017 was \$22,894.38. The report was filed as read. A consensus vote was taken and approved for the Treasurer's Report and will be filed as read.

**Delegate's Report (Beth K)**: 2018 World Service Conference will be held in West Harrison, NY on April 16<sup>th</sup> – April 20<sup>th</sup>. Stepping Stones will be visited by the Conference attendees. The theme is "Al-Anon – There Is No Standing Still", which is an excerpt from a statement made by Lois W.

**Area Highlights** – Delegates share Area Highlights at the WSC. Beth will share some of Iowa's successes and opportunities.

**2018 Service Workshop Wrap-up:** Virginia B. - 62 people attended the Service Workshop. Great workshops were held. Motion was made by Lorraine R. to have a Service Workshop in 2019. Seconded by Jean L. Passed by consensus vote.

**2018 Area Calendars:** Lisa G – \$3.50/each. 112 orders were placed. The printer missed inserting information from District 3. As a result, they reduced the charge and provided additional calendars. Audrey from District 3 will send out the information to Virginia so that everyone has the needed information. Total profit \$157.92.

**By-Law Update:** Katy P. – Legal counsel and several members have met to discuss the language of the By-Laws. Connie H. has provided information from other Areas. The By-Laws were read and discussed. Motion was made by Trisha K. "I make the motion that we accept the By-Laws of Iowa State AI-Anon Family Groups with grammatical corrections." Seconded by Jean L. Vote: 23 approved. The By-Laws will be posted on the Iowa Website once corrections are made.

## **New Business:**

Group Records: Becky V. shared a power point handout about updating Group Records with group changes. WSO now has new forms which were mentioned in her report.

2018 Serenity Weekend & Planning: Beth K - Options were submitted for a discussion and vote to be made regarding the 2018 Serenity Weekend. Option #1: Twin Lakes – Sept 14-16, 2018. Option #2: Wesley Woods – September 21-23, 2018. Option #3: Not to have a Serenity Weekend in 2018. Pros and cons were discussed, including pricing, programs and logistics. A majority vote was taken. The weekend will be held at Wesley Woods on September 21-23, 2018. The usual weekend in September will be reserved at Twin Lakes for 2019.

2018 Spring Agenda: Agenda was discussed. Workshop to be held: Saturday – Mary H – Empowering Ourselves by Using the Legacies and Policy While Seeking Solutions. Sunday – Jean L. and Beth K. – Spiritual Finances at the group level.

2018 Budget: Jean L. presented the 2018 budget. Discussion was held. It was approved with a consensus vote.

Regional Trustee Resume: Beth K. - Discussed requirements to stand for this position. Resumes are due to the Area Chairman by 5/1/18. A vote to confirm Iowa's support of any candidate(s) will be taken at the Spring Assembly if any qualified resumes are received.

Articles of Incorporation Update: Katy P. – Initial Articles were filed in 1973. The latest version was filed in 1993 and may be sufficient for our purposes. More information in March.

Policy Committee: Linda A. – presented the remainder of the proposed changes to the Iowa Area Al-Anon / Alateen Policies and Procedures. Discussion was held. Motion was made by Linda A. I move that all the changes presented by the Policy Committee regarding the Iowa Policy guidelines to be approved and amended by consensus of the AWSC on January 21, 2018. If approved, the manual will be updated and forwarded to the AWSC members and posted on the Iowa Area website.” Motion was seconded by Lisa G. Approved unanimously.

A motion was made to close the meeting at 12:05. Seconded by Tracy HG.
