Balance brought forward was \$25,936.69. Total receipts for the period was \$3,106.42. Total disbursements were \$3,934.42 which brought the total balance forward on May 26, 2020 to \$25,108.69. The report was approved by consensus via a virtual poll.

There was some discussion on the appeal letters that went out and the low return of donations. Because of the COVID 19 pandemic, groups are not meeting face to face at this time which has made donations drop and groups are not able to share the appeal letter to their members. be read during the business meeting at Assemblies.

Voting would be different than usual on the above motions as this is a virtual Assembly. A virtual poll would be presented on the screen for voting. Virginia B., Area Chairperson, reviewed the instructions on how the polling would work. All voting members were asked to vote on each motion using the virtual polling method.
