

**Iowa Area AWSC Meeting
August 8, 2021
Hampton Inn- Marshalltown, IA
Hybrid Meeting**

Virginia B., Chairperson, opened the meeting at 9:00 AM. There were 25 members in attendance, 2 members joined virtually and 23 were voting members of the AWSC. This meeting was held hybrid for the first time, due to the COVID-19 pandemic. The meeting opened with a moment of silence and the Serenity Prayer. The Traditions were read by Jill G. and Michelle K. read the Concepts of Service/Warranties. Virginia B. read the review of etiquette and the AWSC evaluation questions for all members to think about throughout the meeting.

Secretary Report: The minutes from the October 2021 Assembly were e-mailed electronically earlier to be read before the meeting; they were not read during the meeting. The minutes were approved by a consensus by the voting members.

Treasurer Report: The financial statement from May 29, 2021 to July 31, 2021 was presented and discussed. Balance brought forward was \$29,172.51. Total receipts this period were \$3,423.38. Total disbursements were \$2,530.03. Ending balance on July 31, 2021 was \$30,065.86. A correction to the YTD will be made as it did not carry over from the previous report. The financial statement was approved by a consensus of voting members.

Delegate's Report:

Electronic Groups

A complete report, minutes from the breakout groups, and the supporting PowerPoint document had been sent to the DRs and AWSC members regarding the virtual Town Hall on July 14, 2021. From reviewing the minutes from the breakout groups, at first glance, the repercussions of incorporating E groups into our structure are financial, technological, logistical, and linguistic. The power of a group conscience is strongest when it is fully informed. Iowa is right on schedule regarding electronic group's time frame!

Envisioning Our Future

Our AWSC is only as strong as our districts, and districts are as strong as their groups. WSO's Strategic Plan, including shorter-term goals and long-range vision may be reviewed in the World Service Conference Summary on the AI-Anon.org website. The importance of looking ahead was brought to the June Assembly where attendees participated by sharing in small group breakouts and allowed us to explore our goals for our groups as we return to Face to Face meetings and other current topics. It was also intended to help launch our awareness into envisioning a future with electronic groups as a part of the World Service structure. The power and need for active GRs feels even more pertinent now as we highlight the role of the Group Representative as a fundamental shift in the change from electronic meetings to electronic groups.

Chairperson of the Board

A virtual COB reveal took place August 7, 2021 in which both Katy P. and Jean L. were able to attend. WSO revised its budget for the second year in a row. This is not typical for our organization and occurred in response to the financial unpredictability of 2020. The revised budget sees the WSO making

just a bit more in literature sales while expecting a deficit in contributions. The overall deficit to date equals approximately one month of member contributions or 15 days of expenses.

A new task force is forming to focus on Public Outreach in Relation to Social Media, emphasizing the importance of the word 'local' in the expanding reach of a global world. Speaking of keeping it local while thinking global-Jean L., will be involved with the European Zonal Meeting which is being held virtually September 3-5, 2021.

The Iowa Area Inventory Committee received 51 electronic responses and one paper response. The committee will review the results and prepare a presentation to be presented at the Fall Assembly in Des Moines.

Alateen/AAPP: Thank you for your continued service to Alateen in these unusual times. A heart full of gratitude to the AMIAS in Iowa who have stayed certified and thanks to those who have just become certified. All of Iowa's AMIAS were recertified before the WSO cutoff date.

The Area Alateen Serenity Weekend was postponed until May 6-8, 2022 and Camp Wesley Woods has been very generous in moving our deposit yet again due to the pandemic. The date we selected will allow us to have all the facilities that we usually use.

Revision to the Alateen Preamble to the Twelve Steps

The 2021 World Service Conference approved the revision to the Alateen Preamble. Communication will be forthcoming on how to insert the new Alateen Preamble.

Alateen Just for Tonight Bookmark

The 2021 WSC approved creating an Alateen version of the Just for Tonight bookmark, so please ask your Alateen group to send in suggestions as to the content of the new bookmark.

Archives: Ordering of the file cabinets is still in the works. After some discussion regarding transitioning the archival material from paper to electronic, it was decided to table this discussion until a later date.

Two pieces of literature will undergo some changes; The Dilemma of the Alcoholic Marriage (B-4) which will include a preface giving it a historical perspective and secondly our first daily reader, One Day at a Time in Al-Anon (B-6) will have an introduction providing a historical outlook while maintain the enduring spiritual principles of Al-Anon.

Public Outreach: There was a Public Outreach Collaboration via zoom on June 12 which was a very informative and motivating call.

The new Public Outreach campaign will include a new PSA that includes actual members' stories shared while completing the 2018 membership survey. This new PSA will be on the benefits of Al-Anon.

An Iowa Public Outreach virtual meeting is in the plans for late August which will include Alateen Coordinators as well.

Web Page: The Website continues to try to keep up with the rapidly changing meetings in this time of COVID-19. Thank you all who continue to provide updates as the meetings are adjusting to the changes.

District Reports: Reports were submitted electronically but not read by the following DRs: 1, 2, 3, 4, 7, 8, 9, 11, 13 and 14. There were no reports from 5, 6, 10, 12 or 15.

Old Business:

2021 Service Workshop Recap- The theme “What a Concept” with the 12 Concepts and General Warranties were presented by different districts. Members found it very informative on how the Concepts pertain to our everyday life as do the Steps and Traditions. There were 37 members attending the Service Workshop August 7th, 2021 at the Iowa Valley Community College in Marshalltown and many members commented that it felt good to be together in person again.

Serenity Weekend- The theme of HEE HAW (How AI-Anon Works) will be the theme and the event will be at Twin Lakes in Manson, IA., November 5-7th. The camp has made many updates to the campground which will be exciting to see. Registration for the weekend is available on the Iowa Website. This Serenity Weekend will be the first time it has been scheduled at this time of year. It will be interesting to compare the different seasons at the camp.

Thought Force-Email Service/Document Storage – The Thought Force gave a report on their findings and would like to bring forward the following recommendations for discussion and possible action by the AWSC. The Thought Force KBDM documents and spreadsheet were included in the report.

The Thought Force examined multiple platforms and felt two of them meet the goals of the charge, Groups.io and Google Workspace.

We recommend a Task Force be developed to determine ease of use, financial requirements training requirements, and email capabilities of the Google Workspace platform for our Area.

The Thought Force would like to bring forward 3 other recommendations:

- **Recommend a Task Force be developed for the addition of an Area Technology Coordinator. We believe that Iowa is moving toward a future involving more technological aspects. The need for a Coordinator would be to help with the development of more hybrid Area Business meetings, the possible addition of electronic meetings within our**

Area structure, and the necessity of having someone (working cooperatively with the Chairman and Web Site Coordinator) with planning, training and implementation of future technology.

- **Recommend, after an Email/Document platform has been decided, the Web Site Committee review the web site design and possibly assist the Web Site Coordinator in a redesign that would lead more toward reaching newcomers through Public Outreach and less as a place to hold Area/AWSC documents.**
- **Recommend the Web Site Taskforce designed to create generic emails for all Area Coordinators be put on hold until further need arises.**

After much discussion, a consensus was taken and a Task Force for email service/document storage was approved. Members that volunteered to be on the Task Force include Katy P., Virginia B., Connie H., Luanne T., Tracy V., Michelle K., and Jamie V.

Another consensus was taken and approved to have the Web Site Task Force be put on hold and will report back in January 2022.

In regards to the Area Technology Coordinator, the decision was made to have a Task Force for this position. Members that volunteered to work together on this Task Force include Katy P., Virginia B., Lorraine R., Beth R., Audrey U., and Samantha M.

Presentation: 'AWSC Open Conversation'

The floor was opened to all AWSC members for discussion regarding their districts in Iowa. There were comments on how the pandemic has affected many groups and that virtual meetings seem to be the "norm" at this time, yet other groups are looking forward to being back face to face as soon as possible. Comments were made that district meetings are not well attended, in which the opportunity to share how/what other districts are doing to encourage members to attend transpired. Many members enjoyed this time to visit with other DRs regarding hybrid groups, safety factors and anonymity at the virtual meetings.

New Business:

2021 Fall Assembly Agenda- Fall Assembly will be held in Des Moines, IA at the Embassy Suites On the River, October 8-10th, 2021. The host committee from District 7 will be working on the details. There will be a workshop Friday night hosted by District 7, a GR workshop presentation Saturday morning and a workshop Sunday morning on the Concepts by our speaker Betty A.

Regarding the ability to have the Assembly Business meeting on Saturday as hybrid is yet to be determined by the facility accommodations.

Literature at the Fall Assembly

A consensus was taken and approved to have District 7 sell literature at the Fall Assembly 2021 in Des Moines and the Spring Assembly 2022 in Creston to help support the local depot.

Area Calendar for 2022

The need for a calendar in 2022 was discussed and the AWSC members approved by consensus to not have a calendar made for 2022.

2022 Service Workshop

Different dates were discussed for a Service Workshop in 2022. A consensus was taken and approved for the service workshop to be held January 15th, 2022 at the Marshalltown Community College. The theme of "Lighting the Way" will cover service positions at the Group and Area level. The workshops will be to welcome all the new members that have stepped up to their new service positions.

Approval of Iowa AI-Anon Business Meeting Minutes

A discussion of when the Iowa AI-Anon Business meeting minutes should be approved transpired with the decision to continue approving the minutes as we have been. The AWSC minutes will be approved Friday night at Assemblies and the Assembly minutes will be approved at the next AWSC meeting.

Workshop – Electronic Groups

Iowa is right on track with Electronic meeting guidelines. Questions were sent electronically to the AWSC members in advance to aid in the discussion/questions regarding electronic groups. Many of the members found it was difficult to communicate the concern that each group has a voice on how Iowa will move forward on this topic. Members discussed how boundaries would be formed for electronic groups and how the Iowa policies would need to change. A simple question was asked of those in attendance how they felt about electronic groups and would they be in favor of allowing this in Iowa. With the raise of hands, it appeared it is 50/50 in favor of/against including them in the area structure at this time. More answers, questions and more discussion will be coming in the near future.

Unanswered Questions/Review Comments- A lot of good information was shared today. Many members enjoyed the open conversation time. Members enjoyed how they could share concerns with other DRs in regards to how others are coping with the pandemic affecting their groups along with how others stay in contact with all members in their groups and district. Virtual meetings were a common concern for many districts. Members that attended the AWSC meeting virtually, found it worked well and would like to see it continue.

A consensus was taken to close the meeting with the AI-Anon declaration at 1:15 pm.
