

## Vorld Service Conference begins with Clearing the Air Session

- •Maybe we should look to our history to understand the issues
- There were multiple concerns over why the implementation without full information being shared
- It is important to include the fellowship in the conversation whenever possible
- •Unanswered questions need to be answered for full transparency

### World Service Conference begins with Clearing the Air Session

- •Questioning the Board and staff does not mean we don't presume goodwill
- Implementation had unforeseen consequences and felt punitive for some members
- •WSC did not feel all pertinent information was shared.
- •Many members were confused by the decision and difference between policy and procedure

## **Delegate Participation on the Conference Leadership Team**

Task Force provided a report on how Delegates could participate more directly in setting the World Service Conference agenda (WSC). The Task Force recommended three new work groups:

- Education Delegates on CAI Process, Appropriate Topics
- Collaboration Feedback on Preliminary WSC Agenda
- Facilitation Gather, Clarify, & Consolidate CAIs

The WSC agreed by consensus for the Board to move forward with the work groups.

### Choosing a Group Name-Next Steps

In 2024, the WSC approved "Choosing a Group's Name" Policy as relates to identifiers in group names. (motion #3)

Information is always needed to make educated decisions.

At the 2025 WSC, A motion came from the floor calling for a temporary suspension of this motion.

## **Choosing a Group Motion #7**

"Allow group names to continue to include identifiers such as those currently listed on page 28 of the 2022-2025 Al-Anon/Alateen Service Manual (P-24/27) v4(a) including "men, women, parents, adult children, young adults, other gender identification/sexual orientation, etc. with the understanding that in keeping with Traditions Three and Five the groups will welcome anyone affected by someone else's drinking".

This will allow WSC Structure Areas to discuss the implementation of the 2024 WSC -approved "Choosing a Group's Name" Policy.

- Delegates/Areas-hold discussions-receive clarity
- WSO Staff-will continue to review group names
  - Avoid registration of groups with outside affiliations
  - Permit registration of new groups and updates to existing group names that include identifiers such as those listed in the motion.
- 2026 WSC will resume the conversation with Area/group feedback

Past candidates expressed concerns over the Regional Trustee process:







## Local Services-Policy Changes Review

- "Naming a Service" was re-written as "Al-Anon Information Services (AISs) or Intergroups," considering both WSC's and international structure use of the term.
- "Answering Services" and "Information Services" (Intergroups)" were removed, as they were determined to be procedure rather than policy.
- "Employees in Al-Anon Services" became "Service Participation by Employees in Al-Anon Services" with minor edits.



## **15,375 Members within WSC Structure Responded**



Survey results indicated that **96%** of respondents have attended face-to-face/in-person meetings, **60%** online meetings, **22%** phone meetings, and **18%** participated in meetings on the *Al-Anon Family Groups Mobile App*.

## Chosen Agenda Item #1

#### CAI:

Service Participation in the Electronic Hybrid Age Is electronic meeting dominance resulting in loss of fellowship and participation; is face-to-face meeting participation the only avenue for moving toward service commitment participation?

#### **RATIONAL:**

While virtual meetings originally helped overcome obstacles for pandemic Al-Anon recovery, possible drawbacks emerged such as a burgeoning breakdown in quality fellowship, retention of members, continued long-term recovery, mutual aid, and reduction in spontaneous interaction among members which may ultimately lead to lessening service commitment participation. Is Zoom meeting incorporation helping or hurting?

Attracting and retaining Al-Anon members in the 20- to 40-year-old range

## **RATIONAL:**

The 2021 Membership Survey reported the average age of members to be 62.5 years. On average members attended their first meeting at 44.1 years old. How do we not only attract members in the 20- to 40-year-old range to meetings but also encourage them to keep coming back when the current members of the meeting are older.


